- 1) West Zone member State Archery Associations including Maharashtra, Goa, Madhya Pradesh, Gujarat, Daman & Diu, Rajasthan are eligible to recommend a maximum of five (5) candidates for the seminar;
- 2) Maximum two (2) participants from the Associate Members provided the participants work/belong to that area shall participate;
- 3) Participant should be a State Judge. He/she should have an Archery Background and must have basic knowledge of Archery & Archery rules;
- 4) Proficiency in English language; &
- 5) Willing participant is required to submit an undertaking that he/she shall officiate at least one Competition/National Trial/Tournament in a year to be conducted by Archery Association of India, if assigned.

Existing Judges/Technical Officers of the AAI are also welcome to attend the seminar in order to upgrade their knowledge.

Registration Fee
