2 nd Stage of Selection Trial		26-27 August, 2017	To select final team of 3 Archers in each category

Eligibility Criteria

i) Age

Category	Birth Years	Age Group
Cadet Recurve & Compound (B &G)	1 st January, 2000 or later	17 years or below
Junior Recurve & Compound (B &G)	1 st January, 1997 or later	20 years or below

ii) Benchmark Score

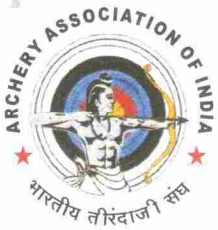
Archers who have scored equal to or above the points mentioned below in any National Championship /National Selection Trials/National Ranking Archery Tournament (NRAT)/State or Unit Championship/ Selection Trials in last three years and in Inter-University Championship (2017 only) are eligible to take part in the trials :-

Category	Recurve Boys	Recurve Girls	Compound Boys	Compound Girls
Cadet	640	600	660	640
Junior	640	600	675	645

In case of State or Unit Championship/ Selection Trial and Inter-University Championship (2017), it is obligatory to submit verification of benchmark scores, duly signed by President/Secretary/competent officials of member State Association/Unit and concerned Universities.

All the participating Archers and Coaches will have to make boarding and lodging arrangements at their own cost. Archery Association of India will provide ground facilities for the trials.

Please ensure that entry, by name of eligible and willing participants should reach on or before 22nd July, 2017 at indian.archery@yahoo.in. Entry received after the deadline will not be entertained. The Final competition format will be circulated upon closing of entries.

It is mandatory for top 8 Cadet and Junior Recurve and Compound Archers (male and female) selected from 1st Selection Trial to attend the coaching camp at SAI, Rohtak from 31st July to 26th August, 2017. Camp with selected team members of 3 Archers in each category will continue till departure of team for Argentina-Youth World Championship.

All participating Archers must carry their passports valid at least for 10 months, authentic document of age proof (in original) and four copies of latest passport size photographs along with their bag and baggage while attending the first selection trials.
